WHEN I FIRST GOT IN TOWN, THERE WAS ABSOLUTELY NOTHING! FOR VETERANS, EXCEPT FOR A BUILDING NEXT TO POST OFFICE DOWNTOWN, WHICH WAS CLOSED! SO NOTHING ANYWHERE TO HELP

THE VETERANS WHO WERE MOSTLY HOMELESS & LIVING ON THE STREETS. YEARS GO BY, THE VETERANS'

BUILDING OPENED UP & NOW THERE WAS PEOPLE HIRED TO GET WHAT THE VETERANS NEEDED.

I WENT IN THE NEWLY-RESTORED BUILDING & FELT GOOD WHEN LESLIE, A VA PERSON, HUGGED ALL THE VETERANS AS THEY CAME INSIDE.

AND WEDNESDAYS, THE VA GAVE VETERANS A FREE LUNCH

PLUS PANTRY FOOD TO BRING HOME TO EAT, & ALSO, PROFESSIONALS WHO CAME IN TO HELP:
